The Occupational Therapy Assistant program is offered through a partnership between Indian Capital Technology Center and Connors State College. Students enrolled in this career major will experience challenging coursework while learning occupational therapy assistant theory, practice and critical thinking skills. Fieldwork opportunities are designed to develop professional behavior, observation skills, a foundation for critical inquiry, and synthesis of knowledge to entry level occupational therapy intervention. Treatment focuses will include a variety of physical and psychosocial dysfunctions across the lifespan.

The Occupational Therapy Assistant Program prepares the student as an occupational therapy assistant who will receive an Associate of applied Science degree through Connors State College. Graduates may then apply to take the National Certification Exam, to be administered by the National Board for Certification in Occupational Therapy (NBCOT). After successful completion of this exam, the individual would be a Certified Occupational Therapy Assistant (COTA), and would request in writing from the Oklahoma State Board of medical Licensure and Supervision an application for state licensure. (See "Disclaimer to Applicants")

Classroom hours for technical course work at ICTC are generally Monday through Friday, 8:00 a.m. - 3:00 p.m. Class and fieldwork hours may vary and the potential exists for some limited learning opportunities that can only be offered during evenings or weekends. In such cases, students are given as much advanced notice as possible. The technical training program is approximately twelve months in length. Classes begin in August.

The instructional format of the technical coursework is lecture with hands-on / interactive activities, laboratory and fieldwork activities. Students will be assigned to and be required to travel to fieldwork sites in several locations throughout the technical training experience.

Students will be concurrently enrolled at ICTC and CSC while completing technical course work. CSC will develop degree plans and will perform degree checks. ICTC and CSC will work collaboratively to assist students in meeting general education and technical coursework required for graduation.

Accreditation Status

The occupational therapy assistant program has applied for accreditation by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA), located at 4720 Montgomery Lane, Suite 200, Bethesda, MD 20814-3449. ACOTE's telephone number c/o AOTA is (301) 652-AOTA and its Web address is www.acoteonline.org. Once accreditation of the program has been obtained, its graduates will be eligible to sit for the national certification examination for the occupational therapy assistant administered by the National Board for Certification in Occupational Therapy (NBCOT). After successful completion of this exam, the individual will be a Certified Occupational Therapy Assistant (COTA). In addition, most states require licensure in order to practice; however, state licenses are usually based on the results of the NBCOT Certification Examination. Note that a felony conviction may affect a graduate's ability to sit for the NBCOT certification examination or attain state licensure.

ACOTE granted the program candidacy status on December 7, 2014. Accreditation status of the program will not be known until immediately prior to the graduation of the first class in July, 2016. Admission priority will be applied in the following manner:

- 1st priority: Applicants who meet all admission requirements and have a completed all of the above identified coursework
- 2nd priority: Applicants who meet admission requirements but lack 3 credit hours (POLS or HIST only) and/or documentation of completed observation experience with OT or OTA**
- 3rd priority: Applicants who meet admission requirements but lack 6 credit hours (POLS and HIST only) and/or documentation of completed observation experience with OT or OTA**

Applicants who are currently enrolled in the semester must provide documentation of in order for coursework to be considered. **Observation experience must be completed prior to admission

Connors State College will conduct transcript reviews. Applicants must be accepted for admission by Connors State College. Approved admission to CSC, however, does not guarantee admission to the Occupational Therapy Assistant program.

Applicants meeting the admission criteria will be scored according to the "Priority Point System", and ranked within each priority area according to the number of points earned. Highest ranking applicants will then be selected for interviews. ICTC/CSC will determine the number of applicants interviewed. A minimum of score of 10 on the interview is required for admission.

Following interviews, each applicant's interview points will be added to their "Priority Points". Selection for admission will be based on the applicant's total score (Priority Points plus Interview score). Applicants will be notified of admission status by letter in April or May.

If selected for admission, continued enrollment is contingent upon a satisfactory background check and sex offender registry check, subsequent fieldwork placement, and required drug screening. Classes begin in August. Attendance at orientation session will be required.

Cost of the technical courses of the program at ICTC is approximately \$4,800 - \$5,100.00 (In-District), plus fees required by CSC

- All students will be required to submit a \$100 deposit to ICTC to complete background checks and hold the position in the program.
- All other payments will be arranged through Connors State College.
- Books, supplies and fees for technical courses are included in the cost.
- Final grades and transcripts will not be released if a balance remains.

*Tuition: \$2,380.00 - \$2,720 (In-District); Books \$900.00; Fees & Supplies \$1,500.00 - Fees & other costs are estimated and subject to change. Cost does not include uniforms, or cost of certification & licensure. Additional transcripting & enrollment fees will be required by CSC. ICTC In-District tuition: \$1.75 - \$2.00 /clock hour; Out-of -District tuition: \$3.50 - \$4.00 / clock hour. OTA program is 1360 clock hours.

ICTC/CSC are not obligated to admit applicants who do not meet the identified criteria for admission or score below 10 on the interview. If positions remain open after all applicants meeting the criteria for admission have been accommodated, ICTC/CSC reserve the right to extend or re-open the application period without advanced notice, and/or admit applicants who do not fully meet admission criteria or score below 10 on the interview. If these applicants are admitted, the right is reserved to admit contingently and/or on a probationary status and/or set stipulations for admission.

An alternate list will remain in effect until the first week of class. Alternates and applicants not admitted to the program must reapply to be considered for later admission.

Certification and Licensure

After completing the required credit hours, degree graduates will be eligible to take the National Certification Exam, to be administered by the National Board for Certification in Occupational Therapy (NBCOT). After successful completion of this exam the individual will be a Certified Occupational Therapy Assistant (COTA). Presently the cost of the exam is \$620 and is paid directly to NBCOT. After completing the certification exam, each applicant must request in writing from the Oklahoma State Board of Medical Licensure and Supervision an application for State licensure. The current fee for state licensure for a COTA in Oklahoma is \$100, paid directly to the state board. Costs of the certification exam and licensure are the responsibility of the graduate and will be paid directly to the appropriate entities.

A felony conviction may affect a graduate's ability to take the NBCOT Certification examination or attain state licensure. The National Board for Certification in Occupational Therapy (NBCOT) offers an "early determination" review to individuals with a felony background who are considering entering an educational program. GENERAL INFORMATION ABOUT ABILITIES NEEDED FOR SUCCESS IN HEALTH CAREERS EDUCATION

A student in health careers education will be learning through direct participation in patient care and as a member of the health care team. To participate effectively as a health care provider, individuals should possess certain abilities which include but may not be limited to:

Vision

adequate to read very small print, diagrams, graphs, and calibrations such as mm and 0.1 ml. Also, must be able to discriminate color changes of skin and body exudates.

Hearing

conversational tones discriminate between different sounds within the body such as breath, heart, fetal heart with use of adaptive medical equipment such as stethoscope; also hear signal alerts on medical machinery.

<u>Smell</u>

to detect and discriminate between odors.

Touch

in order to perceive, through the tactile sense, certain parts of a person's anatomy for the purpose of identifying reference sites for various treatments and/or diagnostic procedures, to collect data during a physical exam, to render personal hygiene measures, etc.

Speak & Write

the predominant language of the geographic area in a clear, concise way during verbal and written communication.

General physical fitness / Gross Motor / Fine Motor

including strength, balance, and agility adequate to endure activities including, but not limited to the following: several consecutive hours of walking, standing, moving, and lifting other persons, pushing and pulling various types of equipment such as wheelchairs, gurneys (stretchers), bending and stooping. Fine motor skills are needed to write, to manipulate small equipment such as syringes, needles, surgical instruments, tubing, etc., and to maintain sterile fields. General physical fitness also including freedom from infectious diseases which pose a significant risk of transmission to others in the work place if reasonable accommodations will not eliminate that risk.

General mental/emotional fitness

adequate to ensure informed judgment and individual competence on the part of the student in accepting responsibilities, delegating activities to others and providing care to patients.

Basic academic skills

Reading & Math: prefer High School or higher grade equivalency level as evidence on approved program assessment exam(s). Skills should include; penmanship legible; word usage (written & verbal) appropriate and correct within sentence structure, words spelled correctly; ability to read and interpret various forms of written communication; working with whole numbers, fractions, decimals, calculation of such things as IV fluid rates, preparation of medication dosages, applying various formulas to determine body mass, etc.



The background check may be shared with fieldwork sites. Information contained in the background check may affect the individual's ability to continue enrollment in the program. In addition, background check results may affect employment or licensure.

4. Drug and Alcohol Screens

Students enrolled in health career programs at ICTC will be required to complete drug and/or alcohol screens. Failure to submit a clear screen at any time may result in immediate dismissal from ICTC. Expenses associated with screens are the responsibility of the student.

5. Services for Students Requiring Accommodations

Adult students requiring accommodations are advised to contact Student Services at 918-687-6383 and/or notify the Program Administrator/ Instructor.

6 Financial Aid

The student is ultimately responsible for the payment of all school expenses at the time they are due.

8. *Accreditation Status / Disclaimer to Applicants of the OTA Program

The occupational therapy assistant program has applied for accreditation by the Accreditation Council for Occupational Therapy Education (ACOTE) of the American Occupational Therapy Association (AOTA), located at 4720 Montgomery Lane, Suite 200, Bethesda, MD 20814-3449. ACOTE's telephone number c/o AOTA is (301) 652-AOTA and its Web address is www.acoteonline.org. Once accreditation of the program has been obtained, its graduates will be eligible to sit for the national certification examination for the occupational therapy assistant administered by the National Board for Certification in Occupational Therapy (NBCOT). After successful completion of this exam, the individual will be a Certified Occupational Therapy Assistant (COTA). In addition, most states require licensure in order to practice; however, state licenses are usually based on the results of the NBCOT Certification Examination. Note that a felony conviction may affect a graduate's ability to sit for the NBCOT certification examination or attain state licensure.

The accreditation status of the program will not be known until immediately prior to the graduation of the first class in July, 2016.
